**Public Hearing:**


ZA-6-07-1555: Gilbert Meredith has requested a Zoning Map Amendment for TMP 090-003, 3.001 consisting of 85.588 acres off Burt Creek Road. Current zoning is RA; the applicant has requested a rezoning of R-2 (Single Family Residential District) for future development of 145 lots, upon annexation ANX-07-005.

Gil Meredith spoke on his application to rezone to R-2. Steve Holder stated the Planning Staff recommendation (as attached) Ken Breeden motioned to recommend approval of this Zoning Amendment with the stipulation to follow the Planning Staff recommendation attached. Jimmy Castleberry seconded the motion. Motion carried unanimously.


