- 2. The Purchaser agrees to be bound by the attached regulations as prescribed in the City's Code of Ordinances and further agrees to any future amendments to said regulations, and such agreement and authorization shall be binding upon the heirs, executors, administrators and assigns of Purchaser.
- 3. The City shall retain title to the columbarium and grants to Purchaser the right to use the columbarium in accordance with the City's regulations referred to above, as they may be amended from time to time.
- 4. The Purchaser or representative(s) assigned by the Purchaser of the deceased shall be solely responsible for the cremation in accordance with the applicable laws of the State of Georgia including an approved size urn to fit inside the niche and for the costs associated therewith. Purchaser may use a funeral home or a cremation service of their choice and such costs will be the responsibility of the Purchaser. The City shall only be responsible for opening and closing the Niche.
- 5. If the Purchaser finds it necessary to relinquish the Niche after payment of the Use Fee and the Niche has not been utilized, the City has the right to release the Niche and the City will refund to the Purchaser the original Use Fee, less \$500.00. If determined at a future date the Purchaser determines to remove the cremains and said Niche is vacated, the Purchaser shall not be entitled to any refund of any part of the Use Fee and the rights of the Niche are released back to the City.
- 6. The City will make reasonable precautions to protect the Niche and its contents from loss or damage but will not assume any liability for causes beyond its control including, but not limited to, acts of God, vandalism, theft, accidents, riots, military actions, or strikes.

- The Purchaser authorizes the City to relocate the columbarium or the cremated remains to another location if relocation should become necessary which may be caused by damage, flooding, construction or reconstruction of additions, or any other reasons seen or unforeseen by the City, and this authorization shall be binding upon the heirs, executors, administrators and assigns of the Purchaser. Any such movement will be performed at the discretion and cost of the City.
- 8. This Agreement constitutes the entire agreement between the parties hereto with respect to the subject matter of this Agreement, and supersedes any prior understanding, commitment or agreement, oral or written between the parties of any official or representative of either of the parties. The Purchaser understands that this Agreement shall be binding upon his/her heirs, executors, administrators, successors, assigns, legal representatives and agents.
- Niche maybe be opened up to two times after the initial inurnment of cremains and shall be accompanied by the
