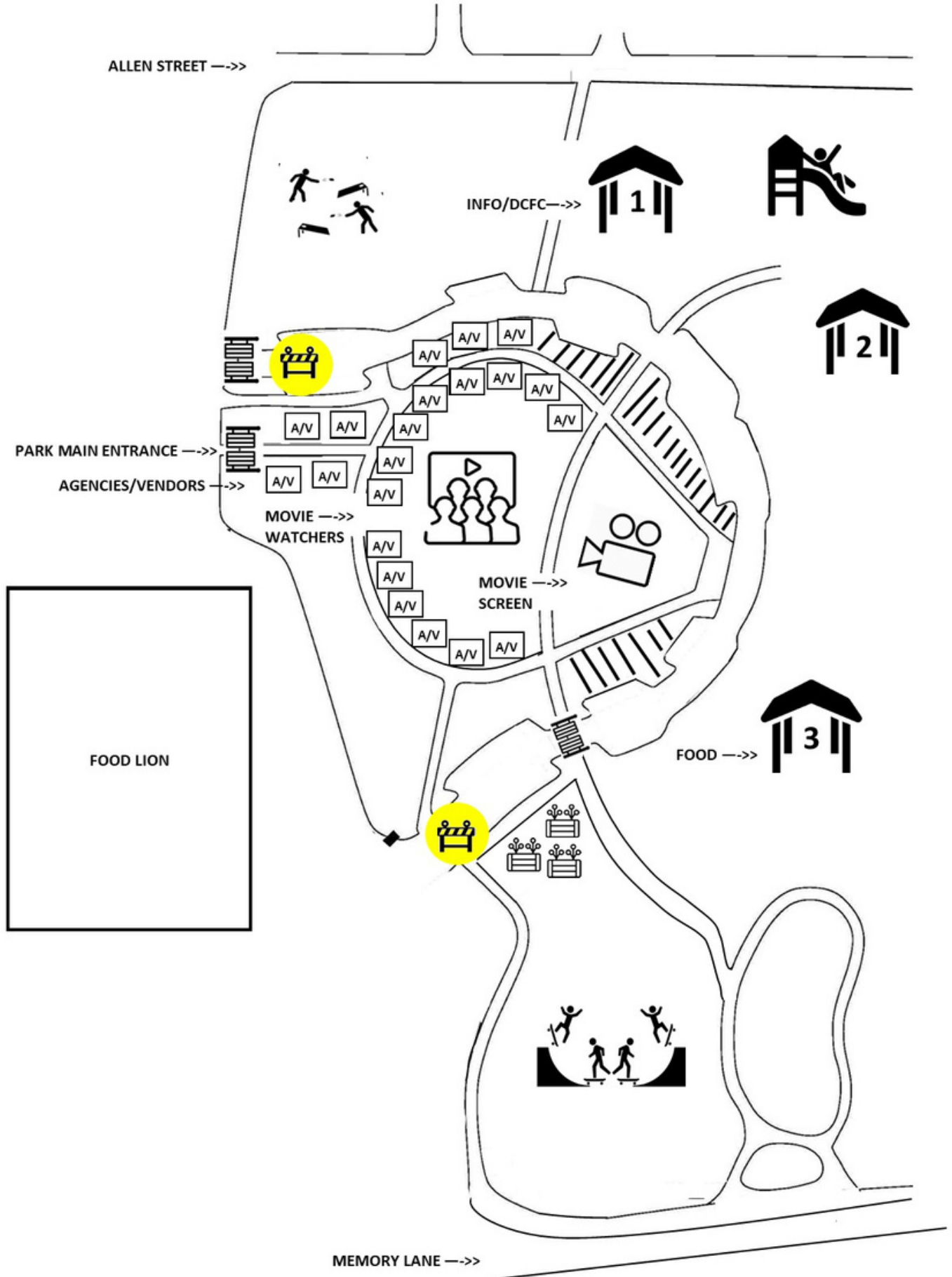

# APPLICANT CONTRACT TERMS & CONDITIONS

1. This agreement shall be effective for the duration of the event.
2. Applicant agrees to comply with all of Dawson County Family Connection's (DCFC) time deadlines throughout the term of this agreement.
3. All goods and services at DCFC events must be family-friendly and suitable for all ages. All goods and services are subject to DCFC's approval.
4. All food vendors must comply by all guidelines, regulations, and fees set forth by the Dawson County Health Department.
5. The placement within the event area is at the discretion of DCFC.
6. DCFC will not be held liable for any damages to the applicant's property throughout the term of this agreement.
- 7. There are no electrical outlets. Power, if needed, will have to be supplied by the applicant.**
- 8. Applicant is responsible for providing all necessary equipment for space (including tables, chairs, tents, drop cords, gas for generator, etc.)**
9. A completed and signed application must be submitted to DCFC.
10. Applicant agrees to comply will all of Main Street Park Rules throughout the term of this agreement.
