CALL TO ORDER: Mayor Grogan called the meeting to order at 5:00 p.m.

ROLL CALL: Present were Mayor W. James Grogan, Councilmember Angie Smith, Councilmember Caleb Phillips, Councilmember Jason Power, Councilmember Mike Sosebee, City Attorney Dana Miles, City Manager David Headley, City Clerk Bonnie Warne, Utilities Dept. Gary Barr, and Roads Dept. Trampas Hansard.

INVOCATION AND PLEDGE: Invocation and pledge was led by Jason Power.

AGENDA: Motion to approve the agenda by: A. Smith/J. Power. Vote carried unanimously in favor.

MINUTES: Motion to approve the minutes of the regular meeting held July 11, 2016 by: M. Sosebee/C. Phillips. Vote carried unanimously in favor.

Pigeon Creek Well #110: Jim Watson spoke for the Pigeon Creek Estates Subdivision and the issues that have occurred with their water since 2005. He presented a petition signed by 14 residents requesting to convert their water system from City Water to Etowah Water.

Millage Rate for Tax Year 2016: On May 2<sup>nd</sup> Council voted to roll back millage rate to zero and not levy a city tax. The City of Dawsonville Official Millage Rate Certification for Tax Year 2016 was calculated at 10.235 with a rollback to zero. Motion to approve executing certification form by: M. Sosebee/A. Smith. Vote carried unanimously in favor.

Proclamation for National Payroll Week: September 5-9, 2016: Mayor Grogan read the proclamation into the minutes and presented it to Ms. Dolly Moses and John Hunt of the Atlanta Chapter of the American Payroll Assoc.

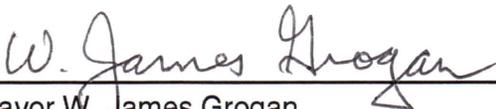
City Clerk Bonnie Warne updated Council that the June 2016 bank statements are all balanced with no discrepancies. We are in the new fiscal year and have started the audit.

Utilities Director Gary Barr informed Council that the water lines on Academy Ave are almost done and that there have been leaks due to the hot dry weather.

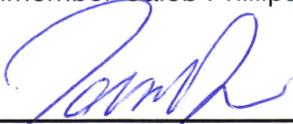
Public Works Trampas Hansard informed Council that all is good and hot.

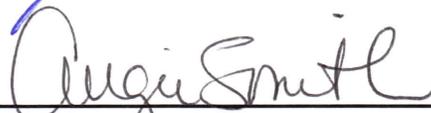

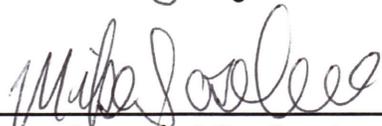

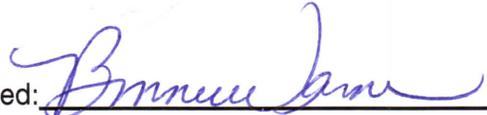
