

**MINUTES
CITY COUNCIL REGULAR MEETING
FEBRUARY 1, 2016
5:00 P.M.**

CALL TO ORDER: Mayor Grogan called the meeting to order at 5:00 p.m.

ROLL CALL: Present were Mayor W. James Grogan, Councilmember Angie Smith, Councilmember Caleb Phillips, Councilmember Jason Power, Councilmember Mike Sosebee, City Attorney Dana Miles, City Manager David Headley, City Clerk Bonnie Warne and Roads Dept. Trampas Hansard.

INVOCATION AND PLEDGE: Invocation and pledge was led by Caleb Phillips.

AGENDA: Motion to amend the agenda #6 Accept 3 Positions: Utilities Maintenance Worker, Roads Equipment Operator I and II by: C. Phillips/A. Smith. Vote carried unanimously. Motion to approve the amended agenda by: A. Smith/C. Phillips. Vote carried unanimously.

MINUTES: Motion to approve the minutes of the regular meeting January 4, 2016 and the work session January 25, 2016 by: J. Power/M. Sosebee. Vote carried unanimously.

Animal Control Board Members: Motion to appoint Gilbert Merritt, Samantha Turner, and Dr. Larry Anderson to the Animal Control Board by: C. Phillips/J. Power. Vote carried unanimously in favor.

Water Rate Increase – Mayor Grogan requested to table per City Manager for a rate study update. Motion to table until March 3rd by: J. Power/M. Sosebee. Vote carried unanimously in favor.

Request Staff to Bid Proposed Park Concept – Motion to direct City Manager David Headley to acquire 3 proposals for architectural drawings on the park and have them present their ideas at the March 21st work session by: M. Sosebee/C. Phillips. Vote carried unanimously in favor.

Accept 3 Staff Positions: Utilities Maintenance Worker, Roads Equipment Operator I and II: Motion to approve filling 3 staff positions by: M. Sosebee/J. Power. Vote carried unanimously in favor.

Howser Mill Subdivision Dedication of Roads – Motion to approve the acceptance of the roads in Howser Mill Subdivision (Howser Mill Road, River Mill Lane, Mill Stone Drive, and Mill Crossing) and waive criteria 1 in the development regulations to wait 15 months from petition to dedicate roads by: J. Power/ C. Phillips. Vote carried unanimously in favor.

Budget Amendment FY 2015-16 for Animal Control \$20K from General Fund Reserves: Motion to approve the \$20K budget amendment for FY 15-16 for Animal Control from General Fund reserves by: A. Smith/C. Phillips. Vote carried unanimously in favor.

Board Renewals: Motion to approve the following Board reappointments to DDA through 2020: Gordon Pirkle, Keith Stone, Cindy Elliott and Dawson County Board of Health for Jack Connor by: M. Sosebee/J. Power. Vote carried unanimously in favor.

Water Department Write Offs for Oct-Dec 2015: Motion to approve authorizing the uncollected debt of \$1030.42 to be written off by: M. Sosebee/C. Phillips. The vote carried unanimously in favor. Exhibit "A"

- Bonnie Warne – Finance Management Level II Certification – 7 Online Classes


City Manager David Headley updated Council on S.P.L.O.S.T. and that the Citizens Discussion Workshop on January 26th was a great meeting with 16 attendees from the city and county.

City Clerk Bonnie Warne updated Council that the Dec 2015 bank statements are all balanced with no discrepancies and the revenues/expenditures are in budget. The L.O.S.T. received in December was \$84,637.50 and the S.P.L.O.S.T. \$81,498.10. Three Draws to GEFA on the DWSRF loan have been submitted for the painting of the water tank. We continue to pay the loans for the park and city hall acquisition from SPLOST for a total of \$62,128.


Jason Power reported that the Board of Health met and discussed the flu epidemic, that there are no cases of rabies and that there is an increase in septic tank permits issued. Mike Sosebee reported that the DDA met and introduced the newest board member John Walden. Mayor Grogan mentioned that the Citizens Workshop had a lot of citizen discussion and feedback and that Mr. Webb still has not completed the downtown survey.

ADJOURNMENT: With there being no further business to attend to the regular meeting closed and adjourned at 5:28 p.m. The motion carried unanimously; J. Power/M. Sosebee.
