CALL TO ORDER: Mayor W. James Grogan called the meeting to order at 5:00 p.m.

ROLL CALL: Present were Mayor James Grogan, Councilmember Angie Smith, Councilmember Caleb Phillips, Councilmember Jason Power, Councilmember Mike Sosebee, City Attorney Dana Miles, City Clerk Bonnie Warne and Public Works Director Gary Barr.

INVOCATION AND PLEDGE: Invocation and pledge was led by Jason Power.

AGENDA: Motion to amend the agenda to remove 11.signage and include 14.Bids for Stegall Rd and 15.Bids on Pole Barn by: J. Power/ M. Sosebee. Motion to approve the amended agenda by: J. Power/ M. Sosebee. Vote carried unanimously.

MINUTES: Motion to approve the minutes of the regular meeting October 5, 2015 and the called meeting/work session October 19, 2015 by: C. Phillips/A. Smith. Vote carried unanimously.

OLD BUSINESS:

Survey of the City Streets Proposals: Proposals were received from MSC, McClure, Davis, and Webb for a survey of downtown. After review of the proposals with the city engineer a recommendation was given for Richard Webb & Assoc. at \$18,000. Motion to approve the proposal from Webb by: M. Sosebee/A. Smith. Animal Control: Attorney Miles drafted an animal control ordinance to be reviewed and updated with changes for the first reading Nov. 16th and second reading Dec. 7th. Attorney Miles mentioned that the ordinance calls to appoint a city veterinarian and 3 member Board.

Resolution to submit an application to the GA Recreational Trails Program funded by GA DNR: Motion to approve by: M. Sosebee/A. Smith. Vote carried unanimously in favor.

GMA Mayors Day Training: DDA Basic Training, Jan. 23rd for John Walden, DDA Board Member, Conference & Training Jan. 22nd- 24th for Mayor Grogan and Jan. 22nd- 23rd for Caleb Phillips. Motion to approve training by: J. Power/A. Smith. Vote carried unanimously in favor.

Bids for Stegall Road: Motion to table to instruct to seek 2 more bids by: A. Smith/J. Power. The vote carried unanimously in favor.

Bids on Pole Barn at Maintenance Shop for Animal Control: Motion to table to instruct to seek 2 more bids by: A. Smith/C. Phillips. The vote carried unanimously in favor.

PUBLIC HEARING:

ZA-2015-C6-00045: Sachinkumar Patel has requested a zoning amendment for TMP 091 010 004 located at the intersection of HWY 9 N and HWY 136 W, from R1 (Restricted Single Family Residential) to HB (Highway Business). 2nd Hearing

The public hearing was unanimously opened by: J. Power/M. Sosebee. Attorney Dana Miles presented the application. Nobody spoke in favor or opposition. The public hearing was unanimously closed by: A. Smith/M. Sosebee. Motion made to approve the zoning amendment application by: C. Phillips/M. Sosebee with J. Power recused. Motion carried unanimously in favor with one abstention 3-0-1.

SPLOST Status Report: The current status of the priority SPLOST projects:

- Parks: Jason Power stated that the plan is to move forward without the grant. There is a local builder that wants to donate time and money into building structures for the park.
- Revitalization of Downtown: Angie Smith stated that Mr. Webb has been approved to do the survey of the downtown City streets.

Staff Reports: City Clerk Bonnie Warne updated Council that the SEP 2015 bank statements are all balanced with no discrepancies and our accounts are in budget. The L.O.S.T. received was \$64,513.50. The audit for FY 2014-15 is to be finished and presented at the Nov 16th meeting.


Gary Barr, Public Works Director, updated Council of the pre-construction conferences: the repair and repainting of the water tank, which they are making progress with the cleaning of the tank and the Academy Ave. water line should start mid-November. The filters at well 110 are working great.

Mayor Report: Mayor Grogan recapped on the upcoming events: Nov 11th Veterans Day Parade, Nov 14th GRHOF Inductee Banquet, Dec 4th GMRC Annual Meeting, Dec 5th Christmas Parade, Jingle Market and Tree Lighting. DDA has issued grant money to Mill Creek Environment and Dawsonville Tavern who have completed their construction. Soul Sisters is not complete yet.







I have attached a PDF of the area I feel you are needing to be included in the "boundary survey" you requested. There are a few roads that are shown on the 1858 survey that I have dashed in red. As we talked about on the phone yesterday, this is a difficult task to put a good number on until we have had more time to discuss the exact needs of the City. My ballpark estimate of the scope we discussed yesterday is below.

I would be happy to come meet with you and/or the City to discuss this scope in more detail. We have done a project similar to this for the City of Acworth. The difficult part of that project was the deed research we did in order to determine the subject properties. The city attorney helped with the research on that one. Also, they were using our individual lot surveys for closing on the purchase of the properties.

Since this is a fairly large scope with a few uncertainties involved, I would recommend contracting an "On Demand Services" contract with set hourly rates. Our typical hourly rates are \$95/hour for office and \$130/hour for field time. Since you are a long time client of ours and municipality work is one of our strong points, I would offer the following discounted rates: \$115/hour for field and \$85/hour for office work. We can discuss this further if you decide you want to move forward with this. I would appreciate the opportunity to talk further about this if you would like. Just let me know if you have any questions or concerns.

SCOPE OF WORK

The scope of this project is to map the existing roads in Downtown Dawsonville, as well as locate and map any and all roads that are still owned by the City. Extensive research will be needed to determine ownership as well. According to the plat provided by the City of Dawsonville, dated 1858, the size of this project is approximately 40 acres, basically centered around the "Old Courthouse Square". An exact price is almost impossible to determine, due to all of the "unknowns" that may present themselves once research and surveying begins. I would approximate a cost of \$9,000.00-\$10,000.00 based on the time needed to locate all of the existing roads, as well as researching and locating the "unused" roads. Barring any inclement weather, I anticipate a 3-4 week turnaround once awarded the project.

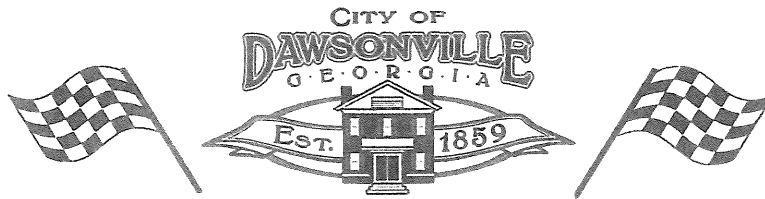

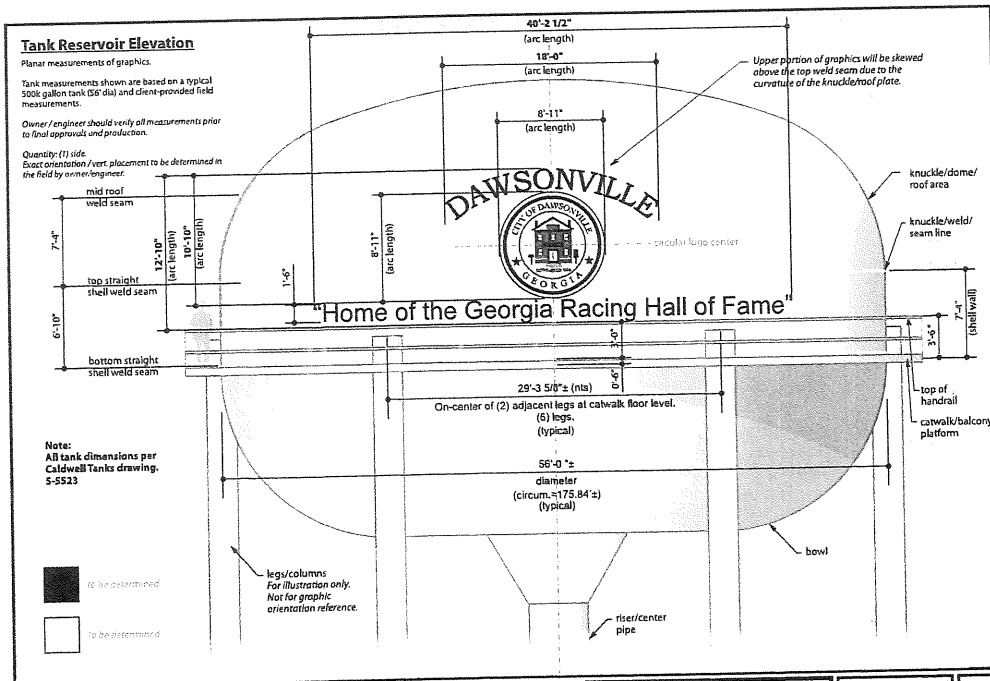
