
NEW BUSINESS – SPLOST VI Project Lists:



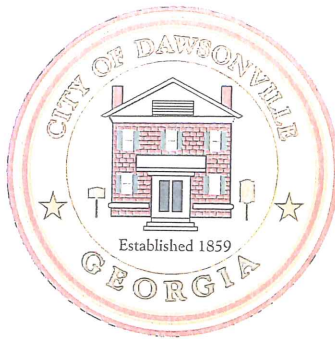
