INVOCATION AND PLEDGE: Invocation and pledge was led by Chris Gaines.

AGENDA: Motion to approve the agenda by: J. Power/M. Sosebee. Motion carried unanimously.

NEW BUSINESS – Mayor Grogan read a press release stating that this is the refinance of the USDA and GEFA water/sewer bonds which we received a "AA Stable" rating from Standard and Poors making an approximate 14% saving (\$1.95 million or present value savings \$684,000).



Motion carried unanimously. Motion to authorize the Mayor and Clerk to execute any other documents related to the 2014 Bonds by: J. Power/M. Sosebee. Motion carried unanimously.

Chris Gaines and Mayor Grogan thanked all those involved in the process for their hours and time to complete this refinance.






