TRADE NAME REGISTRATION

(TO REGISTER YOUR COMPANY AS "D/B/A" - DOING BUSINESS AS)

The State of Georgia requires businesses that are <u>not</u> registered as corporations, limited liability companies, general partnerships, or limited partnerships to register their business names. However, if you <u>are</u> a corporation, limited liability company, general partnership, or limited partnership but are <u>not</u> doing business under that name, you are required to do a trade name registration for the name under which you are operating. City of Dawsonyille cannot issue a business license without this type registration.

Notary is available at the Clerk of Court's Office for those who submit the form in person. Filing/recording fee is \$171.00 (cash, check, money order, or certified bank check). Make check payable to 'Clerk of Superior Court.' The Clerk of Court's office will return the recorded form to you.

#2 -Submit a <u>copy</u>. of the document to Dawson Community News, 30 Shoal Creek Road, Dawsonville, GA 30534 - phone 706.265.3384. A recorded trade name registration must be advertised in the newspaper for two weeks. Cost is \$40.00 (cash, check, money order, credit card) for the advertisement. Make the check payable to Dawson Community News they will provide you with a receipt.

#3 - Submit the receipt and a copy of the recorded trade name registration form to City of Dawsonville, 415 Highway 53 East, Suite 100, Dawsonville, GA 30534 in order to obtain your business license.
