<u>VAR C7-00026:</u> Allen Freisem, with PDK Partners LLC, has requested a density variance for the 2.7 acres located at 1606 Perimeter Road, TMP 093 024 and 093 025. Public Hearing -- Planning Commission on September 13, 2016.

Allen Freisem presented his request; Two adjacent property owners spoke concerning their objections; after a lengthy discussion and concerns about the proposed high density, which greatly exceeds what is allowed by the ordinance, Steve Sanvi motioned to deny the request; Ken Breeden seconded; all were in agreement to deny the request.
